Havant Men's Shed - constitution

1. <u>NAME</u>

The charity's name is the Havant Men's Shed

2. THE PURPOSES OF THE CHARITY ARE:

- a) to provide a workshop and social centre for Havant residents
- b) to help members maintain their health and well being make new friends and enjoy working together on a range of projects
- c) to assist the community of Havant in practical ways whenever possible

3. TRUSTEES

The charity will be managed by a committee of trustees who are appointed at the Annual General Meeting (AGM) of the charity

4. CARRYING OUT THE PURPOSES

In order to carry out the charitable purposes, the trustees have the power to:

- a) raise funds, receive grants and donations
- b) apply funds to carry out the work of the charity
- c) co-operate with and support other charities with similar purposes
- d) do anything which is lawful and necessary to achieve the purposes

5. <u>MEMBERSHIP</u>

The charity shall have a membership. People who support the work of the charity and are aged 18 or over, can apply to the trustees to become a member. Once accepted by the trustees membership lasts for one year and may be renewed. The trustees will keep an up-to-date membership list.

The trustees may remove a person's membership if they believe it is in the best interests of the charity. The member has the right to be heard by the trustees before the decision is made and can be accompanied by a friend.

6. ANNUAL GENERAL MEETING (AGM)

- a) The AGM must be held every year, with at least 14 days' notice given to all members telling them what is on the agenda. Minutes must be kept of the AGM
- b) There must be at least one quarter of the members present at the AGM
- c) Every member has one vote
- d) The trustees shall present the annual report and accounts
- e) Any member may stand for election as an officer or a trustee
- f) Members shall elect a chairman, a treasurer and a secretary and between 1 and 7 other trustees to serve for the next year. They will retire at the next AGM but may stand for re-election.

- g) The trustees must hold at least 3 meetings each year. Trustees may act by majority decision
- h) At least 3 trustees must be present at the meeting to be able to take decisions. Minutes will be kept of every meeting
- i) If a trustee has a conflict of interest they must declare it and leave the meeting while the matter is being discussed and decided
- j) During the year the trustees may appoint up to 2 additional trustees. They will stand down at the next AGM
- k) The trustees may make reasonable additional rules to help run the charity. These rules must not conflict with this constitution or the law

7. MONEY AND PROPERTY

- a) Money and property must only be used for the charity's purposes
- b) Trustees must keep accounts. The most recent annual accounts can be seen by anybody on request
- c) Trustees cannot receive any money or property from the charity, except to refund reasonable out of pocket expenses
- d) Money must be held in the charity's bank account. All cheques must be signed by two trustees

8. GENERAL MEETINGS

If the trustees consider it necessary to change the constitution, or wind up the charity, they must call a General Meeting so that the membership can make the decision. Trustees must also call a a General Meeting if they receive a written request from the majority of members. All members must be given 14 days' notice and told the reason for the meeting. All decisions require a two thirds majority. Minutes must be kept.

- a) Winding up any money or property remaining after payment of debts must be given to a charity with similar purposes to this one
- b) Changes to the Constitution can be made at AGMs or General Meetings. No change can be made that would make the organisation no longer a charity
- c) General Meetings may be called on written request from a majority of members
- d) Trustees may also call a General Meeting to consult membership

9. SETTING UP THE CHARITY

This constitution was adopted on Wed 11th June 2014 by the people whose signatures appear below. They are the first members of the charity and will be the trustees until the AGM which must be held within one year of this date.

Note: The constitution was amended at the second AGM on 6th April 2016 to allow the AGM itself to elect the officers of chairman, treasurer and secretary – see clauses 6(e) and 6(f) above.
